

MY APOLOGIZE TO ALL MALAYSIAN & SELAMAT SEJAHTERA 1MALAYSIA MY NAME IS BALASUBRAMANIAM AND I AM HERE TODAY MAKING THIS PRESS STATEMENT TO EXPOSE THE TRUTH OF MY STATUTORY DECLARATION.

MY FIRST STATUTORY DECLARATION WAS PREPARED BY SIVARASA & AMERICK SIDHU WHO INFORMED ME THAT DATUK SERI ANWAR IBRAHIM HAD ASK THEM TO APPROACH ME AND WANTED TO MEET ME PERSONALY TO HELP THEM BY RELEASING THIS SD AS DSAI WANTED TO DAMAGE DATUK SERI NAJIB'S REPUTATION AND PREVENT HIM FROM REPLACING DATUK SERI ABDULAH BADAWI AS A PRIME MINISTER.

EVERYTHING RETURNED TO NORMAL FOR A WHILE UNTIL A FEW MONTHS LATER, A MUTUAL FRIEND BROUGHT AMERICK SIDHU AND SIVARASA TO MEET ME FOR SOME DRINKS, THEY WERE VERY NICE TO ME AND OFFERED ME A NEW PROPOSAL, SOMETHING WHICH I COULDN'T REFUSE AS IT WAS VERY ATTRACTIVE, RM 1 MILLION CASH AND RM 50,000 PER MONTH. FOR THE NEXT TWO YEARS TO HELP ME OPEN MY OWN BUSINESS IN INDIA, I TOLD THEM YES I AGREE HOWEVER NEEDED A COMMITMENT DIRECTLY FROM DSAI THAT I WILL BE GIVEN A SENATOR SHIP AND A BUSINESS OPPORTUNITY WHEN DSAI BECOMES PM, SIVARASA ARRANGE AN APPOINTMENT FOR ME TO MEET DSAI THE NEXT WEEK WHEN I VISITED KUALA LUMPUR AND DSAI PERSONALY PROMISED ME HE WILL APPOINT ME AS A SENATOR TO TAKE CARE OF INDIAN MATTERS TOGETHER WITH GOBALA KRISHNAN WHO I RESPECTED FOR BEEING A TRUE LEADER TO THE INDIAN COMMUNITY, I WENT BACK TO INDIA WITH SIVARASA & AMERICK SIDHU, I MADE A PRESS STATEMENT WITH MY THIRD SD ACCOMPANIED BY SIVARASA & AMERICK SIDHU AND ALSO A FEW VIDEO'S WHERE I WAS COACHED BY AMERICK SIDHU ON WHAT TO SAY AND
